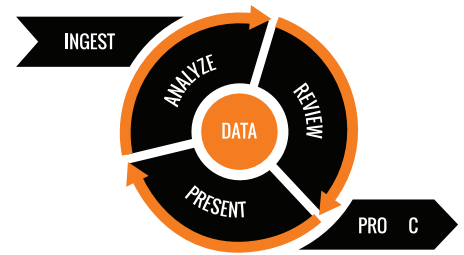

INGEST Ingest large volumes of data. Fast.

- Quickly load data into multiple cases concurrently

- Cull or prioritize order in which documents will be reviewed
- Take a quick peek into document contents during analysis
- Detect & optionally suppress irrelevant files (logos, signature files etc.)

REVIEW Review & classify documents
